## September 28th Club Meeting Minutes: by Mike Schroeder

James Meadows opened the meeting at 7 PM. He stated that this would be last meeting held here at the airfield since daylight was ending early, it was getting cold outside, and no suitable alternative indoor site has been identified. Several members suggested holding meetings at the airfield on a Saturday, early to then be followed by flying. James indicated the board would take that up for consideration.

New member introduction centered on Gary (another Gary) Shindler. Welcome Gary.

#### **Events:**

Tom Blakeney reported on the EDF/Turban/Jet event scheduled for October 17<sup>th</sup>. He apologized for being a little behind the power curve but he contracted the Chinese Virus (Covid-19) and was hospitalized for several days. He has put flyers in the hobby shop(s); suggested making it a no fee event; take donations if offered. He also briefed that this weekend would be an unofficial Saturday electric fly-in with 10-12 outside visitors from the Houston area, making it a good opportunity for fellowship. Airfield will not be closed for other flying.

Ken Knotts mentioned that there is an SPA event at Waco this Saturday that some of our flyers would be participating in.

James briefed the Alliance Airshow status (drive-in only and no static displays. Thanked everyone who offered to help out but would not be needed. It is unfortunate since the airshow has been an excellent opportunity to spread the word about the hobby and the club. James will likely be out at Thunderbird Field for our own event.

The Christmas party is not going to be held as it had been previously. Have no success in locating a suitable location for the Christmas party. Board is proposing a one-of-a-kind event on January 1<sup>st</sup> in combination with the traditional Black Eyed Pea Fly-in. No decision has been made yet on food, etc.

Toys for Tots were brought up and James indicated we would still be supporting this cause.

#### **Reports:**

Officer reports were quite shorter than normal. Rob (VP) was at work; Mike (Secretary) was on (another) vacation; and Ed (Safety) just wasn't here.

Treasures Report by Chris Berardi: Chris briefed that he and Mike were working on a promotional video and expect to have it completed in late October. They have spent approximately \$400 of club funds for equipment and are also using Chris' equipment.

Clubs' checking and savings is in good standing. Membership renewal period is upon us so get out your wallets and renew your membership.

Secretary Report by the fantastic back up Bill Lake: Secretary Report was conducted by Mike's less than capable substitute. Tom Blakeney made a motion to defer the reading of the minutes and it was seconded by Mel Well; voted nearly unanimously by the members despite groans from James and Chris.

#### Show & Tell

Tom Blakeney brought his OV-10 from Motion RC. He built it while recovering from his Chinese virus. He feels it is under-powered (the OV-10 not Virus) but still hopes to maiden flight it on Saturday. He then solicited any jet type donations or giveaways for the event on the 17<sup>th</sup>.

Gary James talked about build and fly kits for hand gliders. He had his example which he launched for a two second - two feet duration. He indicated \$22.50 to build.

Gary then spoke about his RadioMaster (XM-165) Transmitter with full 4.5 in color tough screen; open Tx operating system; voice; USB charger; UART for Geeks (BTSOM); all for \$130 delivered. He got his from Bangood.

#### **New Business:**

James brought up the upcoming elections and need for nominations. Reiterated that nominees have to agree to run and that all positions are open for nominations. Also soliciting for Thunderbird of the Year nominations.

Still working on the lease with the Corp. Has been busy at work so not as far along as he wished. Board has discussed a phased approach to constructing a training facility and toilets. Mentioned negotiating \$35-40K for the building.

Chris brought up the high cost of the port-potty and how we could amortize the building costs.

Kudos was given to the Airfield maintenance team for how good the field always looks.

Ken Knotts suggested that members adhere to established safety rules and stressed that the "No Engine Run" parameters apply to electrics as well as everyone else. There is always the potential for a system failure or operator error that risks sending an airplane into the covered area.





ALL AMA, CORPS OF ENGINEERS AND THE FOLLOWING RULES APPLY TO EVERYONE FLYING HERE.

- 1. Neither the Thunderbirds nor the Corps of Engineers is responsible for accident or injury.
- 2. Place your AMA card in the proper slot above before turning transmitter on.
- 3. All engines must have effective mufflers.
- 5. Fly from the station nearest the downwind end of the runway. In case of a crosswind the first pilot to fly will select the station.
- 6. Aircraft must follow the takeoff and landing pattern in effect.
- 7. Landing aircraft have the right-of-way over aircraft taking off.
- 8. Running aircraft shall not be left unattended.
- 9. No more than 5 pilots shall fly in each designated zone at one time.
- 10. LMA rules are posted in the bulletin board



#### Academy of Model Aeronautics National Model Aircraft Safety Code

Effective January 1, 2018

A model aircraft is a non-human-carrying device capable of sustained flight within visual line of sight of the pilot or spotter(s). It may not exceed limitations of this code and is intended exclusively for sport, recreation, education and/or competition. All model flights must be conducted in accordance with this safety code and related AMA guidelines, any additional rules specific to the flying site, as well as all applicable laws and regulations.

#### As an AMA member I agree:

- I will not fly a model aircraft in a careless or reckless manner.
- I will not interfere with and will yield the right of way to all human-carrying aircraft using AMA's See and Avoid Guidance and a spotter when appropriate.
- I will not operate any model aircraft while I am under the influence of alcohol or any drug that could adversely affect my ability to safely control the model.
- I will avoid flying directly over unprotected people, moving vehicles, and occupied structures.
- I will fly Free Flight (FF) and Control Line (CL) models in compliance with AMA's safety programming.
- I will maintain visual contact of an RC model aircraft without enhancement other than
  corrective lenses prescribed to me. When using an advanced flight system, such as an
  autopilot, or flying First-Person View (FPV), I will comply with AMA's Advanced Flight
  System programming.
- I will only fly models weighing more than 55 pounds, including fuel, if certified through AMA's Large Model Airplane Program.
- I will only fly a turbine-powered model aircraft in compliance with AMA's Gas Turbine Program.
- I will not fly a powered model outdoors closer than 25 feet to any individual, except for
  myself or my helper(s) located at the flightline, unless I am taking off and landing, or as
  otherwise provided in AMA's Competition Regulation.
- I will use an established safety line to separate all model aircraft operations from spectators and bystanders.
