Club Shirts

Coming Soon - Remote Identification

After all of that headache these past few months, the FAA blinked. It wasn't really their fault in that the cause of the delay was more or less out of their hands. Presumably, many of you have also tried to purchase a remote ID device. Mine has been on order for months and there is no availability or shipping information available. Access to a remote ID device was cited as one issue and there were several other points of interest noted in the news release such as the cost being many times higher than the oft quoted \$50.

If you haven't seen it, the AMA has posted a link to a video detailing more of the circumstances around the delay. A quick search should get you the link. Regardless, we won't need to have remote ID in our models (for those of us who may fly on occasion outside a FRIA) for another 6-months or so.

2024 Membership Renewals

Right after Thanksgiving I began accepting your 2024 dues. Due to the volume of renewals I tend to mail out the keys in batches, so you may end up waiting a week as Friday seems to be the best day to get them mailed off. If you have not received your key after a two week period, please call or email me and I'll look into it. The USPS has gotten quite slow even with first class mail and I'm seeing more instances where a letter is taking in excess of a week even for short distances.

The dues remain unchanged for 2024 at least for normal renewals and new memberships; however, the club has discussed the idea of increasing dues but not yet established by how much or when. In part because I need to complete some analysis of what we need to keep our books balanced while providing for contingencies and new projects.

2024 dues are payable by the first club meeting (January 22nd) though many of you have already renewed much earlier. Around 95% submit on the club's web site using the PayPal links and this is the preferred method as it keeps things orderly and efficient.

Regardless of whether you are new or renewing: Please complete and submit a contact/application form! Why, you may ask.... It may not surprise you but people move, change their phones, create new email addresses and don't provide these changes to us. Then keys and letters go missing or confusion mounts when the PayPal verified address doesn't match the membership information. All of this causes delay and rework. Lastly, we have a new option on the membership application for you to accept (or decline) SMS text messages. The promise is to alert the membership only of significant activities and events where that information could be beneficial. For example, the cancelation of an event, lack of power, field closure, and other scenarios. If you don't approve, then we won't send you these messages - hence the need to complete the application form.

The board and many helpful members have completed several key projects this past year including the erection of our new shelter area at the north end of the parking lot. I can tell you that the goals and projects the board have established are for the benefit of our entire membership; our aim is to put our membership dues to full use maintaining and improving the club's flying site, infrastructure, projects, and entertainment throughout the year.

Every club member has a say in the what, how and when we set these objectives. All you need to do is come to a club meeting or communicate with one or all of the board members. We are always in need of leaders from within the membership to help navigate the club to even greater achievements. It takes a village as the adage says; it takes all of us pulling together to get these projects started and completed. This is your cue to become involved in one of the most renown clubs in the nation - please let us know how you would like to help whether mowing and edging, rebuilding run stands, painting fences or managing an event. So, be safe, be friendly and let's enjoy flying.

Academy of Model Aeronautics National Model Aircraft Safety Code


Effective January 1, 2018

A model aircraft is a non-human-carrying device capable of sustained flight within visual line of sight of the pilot or sporter(s). It may not exceed limitations of this code and is intended exclusively for sport, recreation, education and/or competition. All model flights must be conducted in accordance with this safety code and related AMA guidelines, any additional rules specific to the flying site, as well as all applicable laws and regulations.

As an AMA member I agree:

- · I will not fly a model aircraft in a careless or reckless manner.
- I will not interfere with and will yield the right of way to all human-carrying aircraft using AMA's See and Avoid Guidance and a spotter when appropriate.
- I will not operate any model aircraft while I am under the influence of alcohol or any drug that could adversely affect my ability to safely control the model.
- I will avoid flying directly over unprotected people, moving vehicles, and occupied structures.
- I will fly Free Flight (FF) and Control Line (CL) models in compliance with AMA's safety
 programming.
- I will maintain visual contact of an RC model aircraft without enhancement other than corrective lenses prescribed to me. When using an advanced flight system, such as an autopilot, or flying First-Person View (FPV), I will comply with AMA's Advanced Flight System programming.
- I will only fly models weighing more than 55 pounds, including fuel, if certified through AMA's Large Model Airplane Program.
- I will only fly a turbine-powered model aircraft in compliance with AMA's Gas Turbine Program.
- I will not fly a powered model outdoors closer than 25 feet to any individual, except for myself or my helper(s) located at the flightline, unless I am taking off and landing, or as otherwise provided in AMA's Competition Regulation.
- I will use an established safety line to separate all model aircraft operations from spectators and bystanders.
